- E. Patch Cords: Factory-made, four-pair cables; terminated with eight-position modular plug at each end.
  1. Patch cords shall have bend-relief-compliant boots and color-coded icons to ensure Category 6 performance. Patch cords shall have latch guards to protect against snagging.
  2. Data Room: Provide one patch cord for each cable terminated. 50% shall be 2' in length, and 50% shall be 4' in length.
  3. Outlets: Provide one patch cord for each cable terminated. 50% shall be 6' in length, 25% shall be 4' in length, and 25% shall be 10' in length.

#### **Drawing Items**

1. Sheet A6.0 Schedules & Door Elevations: For rooms 106 Meeting and 110 Multipurpose Room, revise the Remarks to read, "PT wainscot at sink – See sheets A7.3 and A7.4 for extents; Wall Protection up to 4'-0" AFF – See Sheet A7.5 for extents; Roller Shades at windows."
